RESOLUTION NO. 1000

A RESOLUTION INTERPOSING NO OBJECTION TO THE "LORALAIN HINGO"  
OF THE OCHS ALUMNI ASSOCIATION STARTING AUGUST, 1981, PROVIDED  
IT CONFORMS TO PC-INP AND MSSD RULES AND REGULATIONS

"WHEREAS, the President of the Ormoc City High School (OCHS)  
Alumni Association and the Principal of the Ormoc City High School  
in a joint communication of June 24, 1981, have requested a permis-  
sion to sponsor the LORALAIN HINGO starting August, 1981, for the  
purpose of raising funds for the completion of the Mini-Cultural  
Center building construction;

permission for fund raising and other benefit activities although  
we have no objection whatsoever to such undertaking specially if

Commander, Integrated National Police, and the Officer-In-Charge,  
Ministry of Social Services and Development, all in Ormoc City;
